- e) For parents who chose to keeps kids home due to the Coronavirus. If you don't have sick reason, after 10 consecutive days they get withdrawn from school. We are following the lead of Howard County officials.

 - b) The county is working out a few things for transportation. The county is also looking to get routing software to see location of bus as they are in route.
